### Direct Cremation ..... \$2,197.00 – \$2,617.00

Our charge for a direct cremation (without ceremony) includes: the basic services of funeral director and staff, transfer of remains within our Service Area, use of licensed climate controlled holding facility up to 7 days and cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard containers.
